## TOURIST TAX

From July 1<sup>o</sup> th 2018 the tourist tax will be applied, established by the Municipality of Albenga with the decision of the Municipal Council n. 25 of 21.03.2018, to the extent determined by resolution of the City Council no. 99 of 22.03.2018.

For the year 2019 the tax will be applied from 01/04/2019 to 30/09/2019.

The tax will be applied to the overnight stays of non-residents in the town of Albenga, for up to five consecutive nights. **The tax rate is € 0,50 per person per night**
